

## NOTIFICATION FOR 1,3 PHENYLENEDIAMINE

The following notification is being circulated in accordance with Article 10.6

<b>5. Title, number of pages and language(s) of the notified document:</b> 1,3 Phenylenediamine(Quality Control) Order, 2021 (1 page, in English)
<b>6. Description of content:</b> 1,3Phenylenediamine is an important dye-intermediate, polymer additive, fibre intermediate and used in photography. Since it is used in dyestuffs required for dyeing of textiles, it is very important to adhere to purity levels indicated in the standard. The excess impurities in the dyes may enter human chain through textiles, impacting the health.If the technical parameters indicated in the standard are not observed, it shall be detrimental to plant life and environment. So, for protection of human health and environment, the standard of 1,3Phenylenediamine needs to be made mandatory. The locally manufactured or imported 1,3 Phenylenediamine shall conform to the Indian standard (IS 17450:2020) and shall bear the standard mark under license from the Bureau of Indian Standards (BIS) as per Scheme-I of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018. The use of standard mark is governed by the provisions of Bureau of Indian Standards Act 2016 and the Rules and Regulations made thereunder. Bureau of Indian Standards shall be the certifying and enforcing authority.

<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> The standard of 1,3Phenylenediamineis being made mandatory to protect the human health and overall eco system.
<b>8. Relevant documents:</b> Quality Control Order for making Indian Standard of 1,3Phenylenediaminespecification (IS 17450:2020), as mandatory is enclosed.
<b>9. Proposed date of adoption:</b> Yet to be decided. <b>Proposed date of entry into force:</b> Six month from date of adoption.
<b>10. Final date for comments:</b> 60 days from the date of upload on WTO website.

**S.O.------(E).**- In exercise of the powers conferred by section 16 of the Bureau of Indian Standards Act, 2016 (11 of 2016) (hereinafter referred to as the said Act), the Central Government being of the opinion that it is necessary or expedient so to do in the public interest and after consultation with the Bureau of Indian Standards , hereby makes the following order, namely:-

**1. Short title, commencement and application.** – (1) This order may be called the 1,3Phenylenediamine (Quality Control) Order, 2021.

(2) It shall come into force on the one hundred and eighty- first day from the date of its publication in the Official Gazette.

(3) It shall apply to goods or articles specified in column (1) of the Table below, but shall not apply to such good or articles meant for export.

**2. Conformity to standard and compulsory use of Standard Mark.**- Goods or articles specified in column (1) of the said Table shall conform to the corresponding Indian Standard specified in column (2) of the said Table and shall bear the Standard Mark under a licence from the Bureau of Indian Standard as per Scheme-I of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018.

**3. Certification and enforcement authority.**- The Bureau of Indian Standards shall be the certifying and enforcing authority in respect of the goods or articles specified column (1) of the said Table.

**4. Penalty for contravention.** - Any person who contravenes the provisions of this order shall be punishable under the provisions of the said Act.
