S.O.-----(E).- In exercise of the powers conferred section 16 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government, after consulting the Bureau of Indian Standards, is of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following Order, namely:-

- 1. **Short title and commencement.-** (1) This order may be called the Steel Wires or Strands, Nylon or ,Wire Ropes and Wire mesh (Quality Control) Order, 2023.
- (2) It shall come into force on the expiry of six month from the date of publication of this notification in Official Gazette.
- 2. Conformity to standards and compulsory use of Standard Mark.- Goods or articles specified in column (1) of the Table shall conform to the corresponding Indian Standard mentioned in column (2) of the Table and shall bear the Standard Mark under a license from the Bureau of Indian Standards as per Scheme-1 of Schedule-II to the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018:

Provided that nothing in this Order shall apply to goods or articles manufactured domestically for export.

Provided that in relation to micro and small enterprises, as defined under clauses (h) and (m), respectively of Section 2 of the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006), it shall come into force on the expiry of twelve month from the date of publication of this notification.

- 3. **Certification and enforcement authority.-** The Bureau of Indian Standards shall be the certifying and enforcing authority for the goods or articles specified in the Table.
- 4. **Penalty for Contravention.** Any person who contravenes the provisions of this Order shall be punishable under the provisions of the Bureau of Indian Standards Act, 2016.
