Item 1

Opening of the meeting

- 1. The fourteenth meeting of the Conference of the Parties to the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal will be held at the Geneva International Conference Centre, 17 rue de Varembé, Geneva, from 29 April to 10 May 2019, back-to-back with the ninth meeting of the Conference of the Parties to the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade and the ninth meeting of the Conference of the Parties to the Stockholm Convention on Persistent Organic Pollutants. The meetings will feature joint sessions on joint issues. The meetings will be opened at 10 a.m. on Monday, 29 April 2019, by the three presidents of the conferences of the Parties.
- 2. Opening and welcoming statements will be delivered.

Item 2

Adoption of the agenda

Organizational matters

(a) Election of officers

(b) Organization of work

- 5. The Conference of the Parties has before it a scenario note for the 2019 meetings of the conferences of the Parties to the Basel, Rotterdam and Stockholm conventions (UNEP/CHW.14/INF/1–UNEP/FAO/RC/COP.9/INF/1–UNEP/POPS/COP.9/INF/1) and a tentative schedule of work for the meetings of the Conferences of the Parties (UNEP/CHW.14/INF/2–UNEP/FAO/RC/COP.9/INF/2–UNEP/POPS/COP.9/INF/2), prepared in consultation with the bureaux of the three conferences of the Parties.
- 6. The Conference of the Parties may wish to decide to meet from 10 a.m. to 1 p.m. and from 3 p.m. to 6 p.m., subject to adjustment as necessary.
- 7. The Conference of the Parties may wish to establish contact groups and other groups, as deemed necessary, and to specify their mandates.

(c) Report on the credentials of representatives to the fourteenth meeting of the Conference of the Parties

- 8. The Conference of the Parties has before it a note by the Secretariat on the status of ratification of the Basel, Rotterdam and Stockholm conventions (UNEP/CHW.14/INF/4–UNEP/FAO/RC/COP.9/INF/5–UNEP/POPS/COP.9/INF/5). The Conference of the Parties may wish to take note of the information provided therein.
- 9. Rule 18 of the rules of procedure provides that the credentials of representatives and the names of alternate representatives and advisers must be submitted to the Executive Secretary of the meeting, if possible not later than 24 hours after the opening of the meeting. The credentials should be issued either by a Head of State or Government, by a minister of foreign affairs or, in the case of a regional political or economic integration organization, by the competent authority of that organization. Please note that the submission of credentials before the meeting would greatly facilitate the advance clearing process by the Secretariat.
- 10. The bureaux of the conferences of the Parties to the Basel, Rotterdam and Stockholm conventions, during their joint meeting held on 15 and 16 November 2018, agreed on the approach that they would follow when preparing the reports on credentials for the meetings of the conferences of the Parties to the Basel, Rotterdam and Stockholm conventions in 2019. The bureaux agreed that when examining the credentials received, they would accept original credentials in good order as well as copies of credentials in good order, on the understanding in the latter case that original credentials would be submitted as soon as possible.
- 11. Representatives of Parties may participate in the meeting provisionally pending a decision by the Conference of the Parties on their credentials.
- 12. The Bureau, with the assistance of the Secretariat, will examine the credentials of the representatives of the Parties at the meeting and deliver a report thereon to the Conference of the Parties for its consideration.

Item 4

Matters related to the implementation of the Convention

13. The Conference of the Parties will consider several sub-items under this agenda item. The sub-items are listed below in the order in which they appear in the provisional agenda, which is not necessarily the order of priority for their consideration by the Conference of the Parties.

(a) Strategic issues

(i) Strategic framework

14. The Conference of the Parties has before it notes by the Secretariat on the strategic framework (UNEP/CHW.14/3) and on a revised draft compilation of information related to the indicators to be used for the preparation of the final evaluation of the strategic framework (UNEP/CHW.14/INF/5). The Conference of the Parties may wish to take note of the information provided in the note and consider the action proposed in document UNEP/CHW.14/3.

(ii) Addressing the entry into force of the Ban Amendment

- 16. (ii) Classification and hazard characterization of wastes

the Harmonized Commodity Description and Coding System on proposals related to the Basel Convention (UNEP/CHW.14/INF/14).

(iii) National reporting

(iv) Electronic approaches to the notification and movement of documents

(v) Marine plastic litter and microplastics²

- 28. The Conference of the Parties has before it notes by the Secretariat on marine plastic litter and microplastics (UNEP/CHW.14/11), on draft terms of reference for the Basel Convention Partnership on Plastic Wastes and draft workplan for the working group of the Partnership on Plastic Wastes for the biennium 2020–2021 (UNEP/CHW.14/INF/16), and on information on the meetings of the open-ended ad hoc expert group on marine litter and microplastics and resolutions of the United Nations Environment Assembly related to marine plastic litter and microplastics (UNEP/CHW.14/INF/53).
