Matters related to the implementation of the Convention: technical assistance

Implementation of decision V/32 on the enlargement of the scope of the Trust Fund to Assist Developing and Other Countries in Need of Technical Assistance in the Implementation of the Basel Convention

Note by the Secretariat

1. In section III of decision BC-13/11, the Conference of the Parties to the Basel Convention welcomed the active engagement of the Joint United Nations Environment Programme/Office for the Coordination of Humanitarian Affairs Environment Unit (JEU) with regard to emergency situations and encouraged its continued cooperation with the Secretariat. In the same decision, the Conference requested the Secretariat, subject to the availability of resources, and invited the Basel Convention regional and coordinating centres, to continue to carry out capacity-building activities with relevant partners, such as the JEU, relevant to the prevention of incidents and enhancing the preparedness of countries to deal with emergencies caused by transboundary movements of hazardous and other wastes and their disposal. The Secretariat was also requested to continue its cooperation and collaboration with the JEU.

2. The Secretariat addresses capacity-building activities relevant to the prevention of incidents and enhancing the preparedness of countries to deal with emergencies caused by transboundary movements of hazardous and other wastes and their disposal in the technical assistance plan for the implementation of the Basel, Rotterdam and Stockholm Conventions for the period 2018–2021.¹ Document UNEP/CHW.14/INF/25–UNEP/FAO/RC/COP.9/INF/24–UNEP/POPS/COP.9/INF/25 contains a report on the implementation of the technical assistance plan for the period 2018–2021 in the biennium 2018–2019, and includes an overview of the above-mentioned capacity-building activities implemented in 2018 and planned for 2019.

3. Information on cooperation and coordination with relevant partners with regards to emergency situations is outlined in document UNEP/CHW.14/20–UNEP/FAO/RC/COP.9/16–UNEP/POPS/COP.9/23.

4. The annex to the present note sets out the interim status of the contributions made to and expenditures incurred by the Basel Convention Technical Cooperation/Special Trust Fund for voluntary contributions, for cases of emergency and compensation for damage resulting from incidents

As at 31 December 2018, a total of 316,930 was available in the Basel Convention Technical Cooperation/Special Trust Fund for use for emergency assistance (BDL), in accordance with paragraphs 2 and 4 of decision V/32 and parts 1 and 3 of the Interim Guidelines for the implementation of decision V/32 on enlargement of the scope of the Technical Cooperation Trust Fund. Table 1 below sets out information on the balance of these funds as of 31 December 2018.
